My LLC was already retooling its charity structure but triggered by the political environment an unintended result was an explosive expansion and improved ability to create assets & connections that can be widely shared. We're now in Phase 3 and along with our name changes are staged launch for our new orgs --a growing network of gap-filling asset delivery & empowerment charities.

So whatever your exempt business previously lacked because from always being denied or excluded *"Is Here Cuz We've Already Built, Created, and/or Secured It."*

This includes *Empowerships™* exclusively for legally registered business concerns that happen to be tax-exempt entities. They were previously extra services offered by the 501c-BizInc & EEF-501c supports that now represent *our own pipeline business assets, resources, and other benefits others continue to deny Us access to or exclude us from.*

- **FOUNDERS ASSOCIATION:** [ATESE](#) is a one-on-one entity where exempt Founders meet with [ATESE/EEF-501c Leadership](#) to openly discuss unique issues to their 501c business, do so confidentially; Geared to new, 1st time and Founders young in their career as an exempt Founding Leader. 501c's established by Federal/State Govt to run Govt programs, manage Govt assets, disburse Govt funds *are not eligible for ATESE*, but welcome to apply to [NCTSB](#)
- **NATIONAL CHAMBER.** [NCTSB](#) is charged with helping its parent & fiscal sponsorship bring recognition for 501c

as the legally registered business concern that it is & build a community of collegial peers,

- **SOLUTIONS WORKING GROUPS:** [501cSBC](#) participants meet as forums to ID operational issues caused by politics or legislation that prevent or stall normal business operation to get them resolved or minimized; 501c's established by Federal/State Govt are not eligible
- **MENTORS COUNCIL:** [501c-MC](#) is Score for Exempts but WAY better, WAY longer, & hands-on led by seasoned exempt professionals with 25-40+ years of experience in myriad types of for profit and tax-exempt work environments.


